USE OF COOKIES

The use of these services implies the complete and unconditional acceptance by the user of this Cookie Policy.

RESIDENZAVISACCI.IT can gather information about users' browsing habits on their sites through tools such as cookies or log files. These tools are uniquely associated to a user and his access device. RIGHTS UNDER ART. 7 OF LEGISLATIVE DECREE NO. 196/2003

Here is the text of Article 7 of the Privacy Code (Legislative Decree no. 196/2003) on the Rights to processing:

- a. you have the right to obtain confirmation of the existence of personal data concerning him, even if not yet recorded, and their communication in intelligible form;
- b. the person has the right to know the source of the personal data, the purposes and methods of treatment, the logic applied in case of treatment with the aid of electronic instruments, the identity of the owner, manager and the representative appointed under article 5, paragraph 2, of the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the State, managers or agents;
- c. you have the right to obtain the updating, rectification or, when interested, integration of data; the cancellation, anonymization or blocking of data processed unlawfully, including data which need not be kept for the purposes for which the data were collected or subsequently processed; 's declaration that the operations in letters a) and b) have been notified, as also related to their contents, to those to whom the data were communicated or disseminated, except where

such compliance is impossible or involves the use of means manifestly disproportionate to the protected right;

- d. you have the right to object, in whole or in part for legitimate reasons the processing of personal data concerning him, even to the scope of the collection; to the processing of personal data for purposes of sending advertising materials or direct selling or for carrying out market research or commercial communication.
